WHEREAS, on or about December 7, 2017, Gurinder Singh, Navdeep Bopari, Fresh to Go and SS Mart, LLC ("Plaintiffs") filed a Complaint in the Superior Court of New Jersey, Law Division, Burlington County, bearing Docket No. BUR-L-2641-17 against the City of Burlington, Mayor Conaway, the City of Burlington Police Department, former Chief of Police Victor Wonderlin, Anna Czajka, Jamie S. Lambing and W. Ruskowski, ("State Court Lawsuit"); and

WHEREAS, on or about April 15, 2019, the Plaintiffs filed a Complaint in the Superior Court of New Jersey, Law Division, Burlington County, bearing Docket No. BUR-L-642-19 against the City, Mayor Conaway, the City of Burlington Police Department, former Chief of Police Victor Wonderlin, Anna Czajka, Jamie S. Lambing and W. Ruskowski, which was subsequently removed to the United States District Court for the District of New Jersey and assigned Civil Action No. 1:19-cv-12203-RBK-AMD ("Federal Court Lawsuit); and

WHEREAS, in response to the State Court Lawsuit and Federal Court Lawsuit, the City filed an Answer denying the allegations set forth therein, and a Counterclaim in the State Court Lawsuit; and

WHEREAS, both the State Court Lawsuit and Federal Court Lawsuit arose in part out of a Redevelopment Agreement between the City and SS Mart, LLC, dated September 2, 2012 ("Redevelopment Agreement"), whereby the City conveyed real property located at Block 148, Lots 7, 8, 9, 10, 19 and 20 a/k/a 200 Federal Street ("Property") to SS Mart, LLC; and

WHEREAS, the parties desire to settle all claims and controversies between them including, but not limited to, the Redevelopment Agreement, the Property, the State Court Lawsuit and Federal Court Lawsuit and any and all related claims which would have been asserted as of the effective date of this Agreement, whether such claims are presently known or unknown; and

WHEREAS, the parties do not admit any liability, but all have reasons to desire an amicable resolution of the matter, including to avoid the costs of further litigation; and

WHEREAS, Plaintiffs and the City of Burlington have engaged in settlement negotiations;

WHEREAS, as a result of those settlement negotiations, all controversies between Plaintiffs and the City of Burlington have been resolved; and

WHEREAS, the Mayor and Common Council of the City of Burlington are of the opinion that the settlement is in the best interests of the City of Burlington.

NOW, THEREFORE, BE IT RESOLVED by the Common Council of the City of Burlington, County of Burlington and State of New Jersey, for the reasons set forth above, that the settlement consistent with the terms set forth in the Mutual General Release and Settlement Agreement be and hereby is approved; and

WHEREAS, the McNeal Mansion and Vicinity Redevelopment Area was declared an Area in Need of Redevelopment pursuant to Resolutions 05-305-R-231, and 249-2016 ("the Redevelopment Area"); and

WHEREAS, the McNeal Mansion and Vicinity Redevelopment Area Plan was adopted pursuant to Ordinance 12-2006, and amended pursuant to Ordinance 07-2017; and

WHEREAS, certain property contained within the Redevelopment Area, identified as Block 203, Lots 1, 2, 2.01, 2.02, and 2.03, Block 207, Lots 1 and 1.01, Block 225, Lots 1 and 3, Block 226, Lots 1, 1.03, 1.05, 1.06, 1.07, 1.08, and Part of 1.02, is subject to a Redevelopment Agreement with Burlington Dream Park, LLC ("the Redeveloper") pursuant to Resolution 190-2019 ("the Redevelopment Agreement"); and

WHEREAS, as part of the environmental due diligence required to develop the site, certain testing is required, some of which is eligible for grant funding; and

WHEREAS, the Hazardous Discharge Site Remediation Funding ("HDSRF") grant is available to public entities to cover the costs associated with completion of preliminary assessments, site investigations, and remedial investigations, which must be performed in the Redevelopment Area prior to beginning redevelopment; and

WHEREAS, the Redeveloper has identified Brinkerhoff Environmental Services, Inc. ("BES") as an environmental assessment partner to complete the HDSRF grant application at no cost to the City, and perform the preliminary assessment using grant funds; and

WHEREAS, BES would perform site inspections, background checks and record reviews in furtherance of the preliminary assessment, and prepare additional grant funding applications for site investigations and remedial investigations as necessary, all at no cost to the City through the use of grant funds, or where applicable, to be billed to the Redeveloper's escrow fund established pursuant to the Redevelopment Agreement; and

WHEREAS, the scope of services proposed by BES dated February 4, 2020; and

WHEREAS, pursuant to the Local Public Contracts Law, N.J.S.A. 40A:11-3, et seq., contracts that are not in excess of \$17,500 may be awarded by resolution without the need for public bidding; and

WHEREAS, while the proposed BES Scope of Services is to be performed at no cost to the City, it nonetheless represents an economic opportunity; and

WHEREAS, the cost estimate of the BES Scope of Services totals \$8,675.00, which is well within the limitations of the Local Public Contracts Law's allowance for an award of a contract by resolution within the need for public bidding; and

WHEREAS, upon consulting the City's Redevelopment Professionals, executing a contract for BES to perform the BES Scope of Services is recommended in order to assist with making progress toward bringing redevelopment efforts to fruition; and

NOW THEREFORE, BE IT RESOLVED, that the Mayor is hereby authorized to execute a contract with Brinkerhoff Environmental Services consistent the scope of services proposed by BES dated February 4, 2020; and

BE IT FURTHER RESOLVED, that upon Brinkerhoff Environmental Services' completion of an application for HDSRF grant funding, and upon approval of the application by the City's Professionals, the Mayor, Administration, Professionals, in conjunction with BES, is hereby authorized to submit the HDSRF grant application to the New Jersey Economic Development Authority and New Jersey Department of Environmental Protection.
