ALL UNSCHEDULED MEETINGS WILL BE DULY ADVERTISED AND POSTED IN ACCORDANCE WITH CHAPTER 231, P.L. 1975, THE OPEN PUBLIC MEETINGS ACT

Due to the restrictions necessitated by COVID-19 it is anticipated that the Land Use Board may conduct remote public meetings.

Consistent with N.J.A.C. 5:39-1, et seq., annual notices are to be revised to contain clear and concise instructions for accessing anticipated remote public meetings, the means for making public comment, and where relevant documents, if any, will be made available.

Plans and application materials for matters to be heard by the Land Use Board at remote public meetings will be electronically available for public review on and through the City of Burlington website. Members of the public may also contact the Land Use Board Secretary at [lubsecretary@burlingtonnj.us](mailto:lubsecretary@burlingtonnj.us) or call directly at 609-386-0200 Ext. 147 to receive a hard copy of the application and supporting material by mail or drop/pick-up by appointment.

If members of the public wish to offer a public comment at a remote public meeting, members of the public are encouraged to attend the Land Use Board meeting virtually. Any member of the public who wishes to submit a public comment for a Land Use Board meeting will be provided the ability to do so during a specific portion of the meeting.

Members of the public looking to offer a comment at a remote public meeting must follow the steps for each meeting which will be available on the City website, including registering as an attendee prior to the scheduled meeting through Zoom or by dial-in numbers that will be available on the City website prior to each meeting.

For individuals who cannot register for Zoom digitally or dial into the remote public meeting, they may submit written comments/questions by contacting the Land Use Board Secretary via email at [lubsecretary@burlingtonnj.us](mailto:lubsecretary@burlingtonnj.us) prior to the meeting. The comments/questions must include the individual's name and address and will be read into the record.

Consistent with N.J.A.C. 5:39-1, this annual notice is to be posted on the City website and on the door of the main public entrance to the building where the Land Use Board's regular public meetings are held, along with the door for any designated and clearly delineated handicap-accessible entrance.
